ADMISSION & APPLICATION

The main admission requirements are:

- 2 years of professional experience in management or healthcare
- Bachelor's degree from a university or technical college with a minimum of 180 ECTS (or equivalent academic degree)
- Proof of sufficient English language skills
- Letter of motivation

STUDY FEES

The programme fees for 18 months of study including all learning materials are € 19,800 for EU/EEA students and € 21,600 for Non-EU/EEA students in total. An extra one-off fee of € 280 for our diversity training and an enrolment fee of € 250 is added to the tuition fees.
